bargain, sell and release unto the said *V.P. Hudson*

All that certain piece parcel or lot, of land situate  
lying and being in the State of South Carolina  
County of Greenville in Butler Township about seven  
miles east of the City of Greenville on head waters  
of Rocky Creek, waters of Enoree River, known and  
designated as Tracts #3 and #6 of the J.L. Vaughan  
farms on a plat thereof made by W.L. Baldwin dated  
October 1918 and recorded in the R.M.C. Office for  
Greenville County in Plat book, E page 110 and  
having, according to said plat the following metes  
and bounds: Beginning at an iron pin in  
road at corner of lands 100.00 or formerly owned  
by John L. Ferguson and running thence with said  
road N. 52 1/4 E. 2.87 Chs. to iron pin thence N. 56 3/4 E.

Chs. to iron pin, thence S 7 1/2 E. 2.7. 10 Chs. to the  
beginning corner and containing 65 acres more
