*Dollars, to be paid on or before five years after date.*

*Aug 28, 1928*  
 with interest thereon, from *Aug 28, 1928* at the rate of *6%* per cent. per annum, to be  
 computed and paid *monthly*.

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
 interest be at any time past due and unpaid, then the whole amount evidenced by said note..... to become immediately due at the option of the holder hereof,  
 who may sue thereon and foreclose the mortgage; said note further providing for an attorney's fee of

*two percent* besides all costs and expenses of collection, to be

*Allen J. Graham and W. S. Griffen as Trustees for the Young Men's Christian Association*, *at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents, do grant,*  
*bargain, sell and release unto the said *August 28, 1928*, *W. Smith, W. P. Miller, Allen J. Graham**  
*and W. S. Griffen, as Trustees for the Young Men's Christian Association*. *All the several lots of land*  
*situate in Ward One, at the City of Greenville as*  
*follows:*

1. *That certain lot or parcel of land situate on the west side of North Main Street in the city of Greenville, County and State aforesaid fronting Sixty-seven feet on North Main Street*

2. *That certain lot or parcel of land situate on the west side of North Main Street having a frontage of ten feet on Main Street and running back two hundred feet to the center of an alley. The above two lots having been conveyed to said Trustees by Thomas S. Jones by deed dated May 1, 1924 recorded in office of R. M. C. for Greenville County in Vol 102 page 140, reference being made to said deed for more full description by metes and bounds.*

3. *That certain lot of land situate on the west side of North Main Street fronting sixty-seven feet on Main Street, being the same lots conveyed to said Trustees, mortgagors herein, by Margaret S. Parker by deed dated May 13, 1924 recorded in said office in Vol 102 page 13. Reference being made to said deed for a more full description by metes and bounds.*
