at the rate of 8 per cent. per annum, to be computed and paid until paid in full all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note, to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of

ten dollars, and witness, D. C. Dacus, at the rate of 10 per cent. per annum, to be added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage; as in and by the said note, reference being thereunto had, as will more fully appear.)

Said lot having a frontage of 50 feet on Highland Avenue and running back in parallel lines 12.5 feet to an alley and being the same lot of lands conveyed to me by James McPherson by deed dated May 1st 1925 and recorded in the R. M. C. Office for Greenville County in vol. 98 page 154
