 interest be at any time past due and unpaid; then the whole amount evidenced by said note..... to become immediately due at the option of the holder hereof, who
 may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of ten per cent.

 added to the amount due on said note....., to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any
 part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage; as in and by the said note....., reference
 being thereunto had, as will more fully appear.)

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents, do grant,
 bargain, sell and release unto the said Jas M. Richardson, his heirs and assigns

all that certain piece, parcel or lot of land in Ward two of
 the City of Greenville, County and State aforesaid; Beginning
 at a point on the eastern side of Lavinia Avenue, 68.2
 feet northerly from the northeast corner of Lavinia Avenue
 and Franklin Street, and running thence along lot formerly
 belonging to Harry Sciffer to a point on Franklin
 Avenue, 58.2 feet from where Franklin Avenue changes
 direction; thence along Franklin Avenue 53 feet, more or
 less, to a point on Franklin Avenue; thence by a
 straight line to a point on Lavinia Avenue, 52 1/2 feet
 from the beginning corner; thence along Lavinia Avenue
 52 1/2 feet to the beginning.

Also: All that certain lot of land in Ward two of the City of
 Greenville, County and State aforesaid: Beginning at a stake
 at the corner of Franklin Avenue and Lavinia Avenue and
 running thence in an easterly direction with Franklin
 Avenue 155 feet to a stake on 10 foot alley; thence
 in a southerly direction with said alley 100 feet to a
 stake at corner of lots 33 and 34; thence with line of lots
 33 and 34, in a westerly direction, 155 feet to stake 3 on
 Lavinia Avenue; thence in a northerly direction with Lavinia
 Avenue 60 feet to the beginning corner and designated as
