and with interest from date at the rate of eight per cent per annum, payable Semi-annually on the day of March and September of each year, past due principal and interest to bear interest at the rate of eight per cent per annum as reference being had to said note will more fully appear; default in any payment of principal or interest to render the whole debt due at the option of the mortgagee.

Beginning at an iron pin at the Northeast corner of North Main Street and Tremont Avenue, and running thence along the North side of Tremont Avenue, S. 69°-25' E. 175 feet to an iron pin; thence N. 19°-55' E. 120 feet to an iron pin; thence N. 69°-25' E. 175 feet to an iron pin on the East side of North Main Street; thence with the East side of North Main Street, S. 19°-55' W. 120 feet to the Point of beginning.
