September 26th 1924 and recorded in the Office of B. M. S. for

1924 and recorded in the said Office for Greenville County in
Deed Book 87 at Page 146 & also G. M. Burns and said
tract lying south of Burke Bridge Road and conveyed the
same to him by deed dated November 10th 1924, and recorded
in Deed Book 91, Page 90, B. M. S. Deeds for Greenville County,
& still own and now mortgage all of said tract lying south
of Burke Bridge Road. This mortgage is an additional loan
from The Carolina Loan & Trust Company, & note on the
same eight per centum (8%) to be paid to said
Company.*
