THIS INDENTURE, made this 15th day of May A. D. 1926
by and between E. C. Case

WITNESSETH, Whereas, the said party of the first part is indebted to said MECHANICS BUILDING AND LOAN ASSOCIATION in the sum of Six Thousand (\$6,000.00)

Dollars, money loaned this day, with interest thereon from this date at the rate of eight per cent. per annum, payable weekly,

the payment whereof the said party of the first part is anxious to secure:

Now, therefore, in consideration of the premises, and in further consideration of one dollar to him in hand paid, the receipt whereof is hereby acknowledged, the said party of the first part has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the said party of the second part all that certain piece, parcel and lot of land lying in Greenville County, in the State aforesaid, as follows, to-wit:

All that certain lot or parcel of land situate, lying and being near the City of Greenville on the north side of the Augusta Road, in the County and State of South Carolina and being known and designated as lot Number fifty-eight of the Poinsett Realty Company property, known as Poinsett Office Place and shown on a plat recorded in the office for Greenville County in Plat Book "E," page 137, and containing the following metes and bounds, according to said plat, to wit:

Beginning at a point on the north side of the Augusta Road which point is 1156 feet from the northeast corner of Papers Street and Augusta Road and is the joint corner of lots nos. 58 and 57, and thence thence west August Rd S. 46-21 E., 78 feet to an iron pin joint corner of lots nos. 56 and 57; thence with the joint line of lots nos. 56 and 57 N. 46-21 E., 200 feet to a point in line of lot no. 53; thence with joint line of lots nos. 57 and 53, N. 46-21 W., 78 feet to an iron pin, joint corner of lots nos. 53, 57 and 58; thence with the joint line of lots nos. 57 and 58, S. 46-39 W., 200 feet to the point of beginning.

Subject to the restrictions contained in deed by Poinsett Realty Company to J. H. Simpson recorded in Deed Book Volume 64 page 313. This being the same property conveyed to me by Edith Cleaton Klein by her deed dated February 25, 1925, and recorded in the R. M. G. Office for Greenville County in Deed Book Volume 105 page 221.
