Dalton, and having the following metes and bounds: Beginning at an iron pin on Douglas Avenue; thence with Douglas Avenue N. 44-02 W. 350 feet to iron pin; thence S. 46-03 W 60 feet to iron pin; thence S. 44-02 E. 350 feet to iron pin on Franklin Road; thence N. 46-03 E. 60 feet along Franklin Road to iron pin at beginning corner being the same conveyed to me by J. H. Stone by deed dated December 10, 1925, recorded in Book 1155 page 529.
