WHEREAS, *J. Jas. & Tilson*, in and by *27.4* certain *February* note in writing, of even date with these presents, *ans.* well and truly indebted to *Morgan Austin Company* in the full and just sum of *Five hundred thirty one and 3/10 (\$531.30)* Dollars, to be paid *12 months after date*, for building material, etc, used in erection of residence on lot hereinafter described.

with interest thereon, from *date* at the rate of *8* per cent. per annum, to be computed and paid *26.2.1 - January* *month* until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid; then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of *ten per cent* *but not more than \$6.00* besides all costs and expenses of collection to be added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is recited under this mortgage; as in and by the said note, reference being thereunto had, as will more fully appear.)

NOW, KNOW ALL MEN THAT *J. Jas. & Tilson* in consideration of the said debt and sum money aforesaid, and for the better securing the payment thereof to the said *Morgan Austin Company*,

according to the terms of said note, and also in consideration of the further sum of Three Dollars, to *MLC*, the said *Jas. & Tilson*.

in hand well and truly paid by the said *Morgan Austin Company* at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said *Morgan Austin Company*,

all that lot of land situate in the County of Greenville, State aforesaid, being Lot No. 23, as shown on a plat of a subdivision, known as San Souci Highland, fronting on a road leading from New Station by Pinhook Spinning Company to Buncannon Road, and having the following lines, courses and distances, to-wit:-

Beginning at a stake on said road, corner of Lot No. 24, and running thence with line of Lot No. 24, S. 81° 30' E. 183 feet to stake on alley, corner of Lot No. 24; thence with line of said alley, in a northwesterly direction, 58 feet to a stake, corner of Lot No. 22; thence N. 75 W. 185 feet to stake on said road, corner of Lot No. 22; thence with said road, 72 feet to the beginning corner, and being the same lot decided to me the 12th day of April 1926 by J.
