WHEREAS, I, the said J. D. Gilbreath
 in and by myself certain
 even date with these presents,

well and truly indebted to
 Norwood National Bank of Greenville, S. C.

in the full and just sum of Ninety-five hundred (\$9500.00)

Dollars, to be paid November 24th, 1926.

with interest thereon, from Maturity at the rate of 7 per cent. per annum, to be
 computed and paid Semi-Annually from May 24, 1924

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
 interest be at any time past due and unpaid; then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who
 may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of reasonable

beyond all reasonable expenses, besides all costs and expenses of collection to be
 added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any
 part thereof, be collected by an attorney or by legal proceedings of any kind, of which is secured under this mortgage; as in and by the said note, reference
 being thereunto had, as will more fully appear.

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Norwood

National Bank of Greenville, S. C., according to the terms of said note, and also in consideration of the sum of Five Dollars, to me, the said

J. D. Gilbreath, in hand well and truly paid by the said Norwood National Bank

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents, do grant,

bargain, sell and release unto the said Norwood National Bank of Greenville

South Carolina. All that certain lot of land in the
 City of Greenville, County and State of South Carolina, on Buncombe
 Street, Beginning at a stone corner of Buchanans lot
 And running thence with Buncombe St N. 34 W. 55 feet to
 stake, thence S. 55.51 W. 102.1 feet to stake, thence S. 5 W.
 67 feet to stake, thence S. 15 E. 41 feet to stake, thence N.
 28 E. 64 feet to stake, thence N. 61 E. 58.5 feet to the
 beginning corner. Plat of said property by R. C. Dalton,
 April 1st, 1922, delivered herewith, this being the lot
 on which is located my Apartment house and being a
 part of the lot of land conveyed to me by Fannie G. Gunn
 by deed dated Jan. 18, 1897, recorded in R. M. S. Office for
