All that certain lot of land situate, lying and being in the County and State aforesaid, on Ward Five of the City of Greenville, on the North side of Perry Ave., said more particularly described as follows: Beginning at a stake on the North side of Perry Avenue, which point is 36.7 feet in a northerly direction from the intersection of Perry Avenue and Ware Street, and running thence in a westerly direction with Perry Ave. 108.2 feet to a stake on corner of lot of J. F. Gleason; thence with line of his lot, in a northerly direction, 114.3 feet to a stake on Ware Street; thence with said Ware street in a southeasterly direction 50 feet to a stake on corner lot of lot of the City of Greenville; thence in a southwesterly direction with line of lot belonging to the City of Greenville, 45.7 feet to the beginning corner.
