*25 W., one hundred and thirty-nine and two-tenths*  
*(139.2) feet to an iron pipe; thence S. 23-55 E. two*  
*hundred and seven and one tenth (207.1) feet to an*  
*iron pipe; thence with line of Thruston property,*  
*N. 64-36 E., one hundred and thirty-nine and six*
