

bearing date November 6, 1903, and recorded in the office last above mentioned on December 12, 1903, in Deed Book LLL at page 120, the said William Durham having intestate and the undivided interest of his widow and children in said land having passed to me, the said R. E. Johnston, in the records put forth in reference to their 213½ acre tract last above described, all of which will never fully appear by reference to judgment roll No. A. 2201" in the office of the Clerk of Court for Greenville County, and the deeds recorded in the office of the Register of Mesne Conveyances for Greenville County in Deed Books "KKK at page 174, and "LLL at 717.

25. Also that tract in Glassy Mountain Township, on headwaters of North Saluda River, containing 63 acres, more or less, and having the following metes and bounds according to a plat thereof prepared by Will D. Neves, Surveyor, dated March 29, 1904, and herewith delivered, to-wit:

Beginning at a corner of Mrs. John Plumby's land and running thence in a south-westerly direction along line of the William Howard land to a hickory 3 x 0 m (gone); thence S 5¾ W along line of the Rachael Lindsey land 20.20 chains to a Walnut, 3 x 0 m; thence S 63 E 8.44 chains to a stone 3 x 0 m; thence N 85½ E along line of the John Bridgeman land, 5.70 chains to a stone 3 x 0 m; thence N 15½ E 1.35 chains to a poplar, 3 x 0 m; thence N 88½ E 5.22 chains to a stone 3 x 0 m; thence S 56 E (still along the line of the John Bridgeman land) 10.00 to a poplar S 3 x 0 m, which is a corner of Berry Hembree's land; thence following the line of the said Berry Hembree land in a general north-westerly direction with one course in a northeasterly direction, as shown on said plat, to the beginning corner; this being a portion of the tract of land conveyed by Peter Gosnell to Rachael Summey, by deed May 27, 1872, recorded, Register of Mesne Conveyances, Greenville, South Carolina, February 25, 1904, Deed Book "LLL" at page 424, and conveyed by the said Rachel Summey to Isaac Bellew by deed Sept. 3, 1874, recorded in office last above mentioned on Oct. 5, 1874, in Deed Book "FF" at page 647, and conveyed by the said Isaac Bellew to Jacob Bellew by deed bearing date March 22, 1875, recorded in office last above mentioned, August 9, 1878, in Deed Book "II" at page 745, and conveyed by said Jacob Bellew to Martha J. Bellew and kindness Lydia Ann Bellew by deed bearing date Aug. 1, 1878, recorded in the office last above mentioned Aug. 9, 1878, in Deed Book "II" at page 747; a proceeding having been brought by said Martha Jane Peace (formerly Martha J. Bellew) by her guardian ad litem, E. E. Peace, against the said Kindness Lydia Ann Bellew for the partition of the said tract of land in the Court of Common Pleas, Greenville County, South Carolina, all of which will more fully appear by reference to Judgment Roll number 11, 218, in Clerk's Office, Greenville County, and a decree having been rendered therein by said Court ordering sale of said tract of land and same having been accordingly sold to J. W. Bridgman, and conveyed to him by D. P. Verner, Master of Greenville County, in obedience to said decree, by deed June 18, 1898, recorded in office of Register of Mesne Conveyances for Greenville County, on April 22, 1904, in Deed Book "KKK" at page 67; said tract of land being described in said deed as containing 75 acres, more or less, but proving upon actual survey to contain 140 acres, more or less; the said J. W. Bridgeman having thereupon conveyed the said tract of land to A. A. Gosnell, by deed Apr. 8, 1904, recorded in office last above mentioned on June 19, 1904, in Deed Book "LLL" at page 722; and the said C. A. Gosnell having conveyed this 63 acre tract to me, the said R. E. Johnston, by deed April 22, 1904, recorded in office last above mentioned on June 16, 1904, in Deed Book LLL at page 701; the said C. A. Gosnell having previously conveyed to me, the said R. E. Johnston, another portion of said tract, containing 47½ acres, more or less, by deed bearing date June 11, 1904, recorded in office last above mentioned June 18, 1904, in Deed Book "LLL" page 723 as herein-above set forth."

26. Also all that tract in Glassy Mountain Township on the waters of North Saluda River adjoining the tract last above described and containing 40 acres, more or less: Beginning on a chestnut 3x and running thence with a line of the William Howard tract last above described to a stone 3x in the road; thence with said line to a sourwood 3x; thence with the Rachael Lindsey line to a stone 3x; thence with said line to the "Wheeler Hickory" 3x; thence to a white oak, 3x (Hulda Lindsey corner); thence with the branch to an ash 3x; thence with a line of the William Howard tract to a stone 3x; thence to a chestnut 3x; thence with the dividing line to the beginning chestnut; this being the other half of the eighty (80) acre tract above described as having been conveyed by James Gosnell to Calvin Howard on Jan. 10, 1880, and by said Clavin Howard to Decatur Howard and William Howard on Feb. 6, 1888; the said William Howard having released to the said Decatur Howard his undivided one-half interest in the last mentioned forty (40) acre tract, by deed of Feb. 2, 1899, recorded June 15, 1904, in Deed Book LLL at page 709; and the said Decatur Howard having conveyed said tract to J. C. Prewette, by deed Jan. 2, 1904, recorded June 15, 1904, in Deed Book LLL at page 696, and the said J. C. Prewette having conveyed the said tract to me, the said R. E. Johnston, by deed April 4, 1904, recorded June 15, 1904, in Deed Book LLL at page 695.

27. Also those two tracts on Gap Creek of North Saluda River, containing respectively, 77 acres and 68 acres and having the following metes and bounds, respectively, according to two plats thereof prepared by Will D. Neves, Surveyor, bearing date April 22, 1904, and herewith delivered, to-wit:

First that tract beginning on a white oak 3x on (down) on Gap Creek at the top of the shoals, and running thence N 10 E 3.00 to a poplar 3x om on Portman Howard's corner; thence along the line of Portman Howard land N 20 E 35 chains to a hickory 3x om (gone) on the corner of the Portman Howard land; thence N 78 E 21.50 chains to a stone 3x om on or near a ledge of large rocks; thence S 37 E along the line of the land of the Harris Pittman land 17.00 chains to a chestnut 3x om (down); thence S 48 E along the line of the land of the Timothy Pittman land 6.00 chains to a maple station on Gap Creek, near the "Winds"; thence down said Gap Creek following the meanders thereof to the beginning corner, containing 77 acres, more or less; this tract lying wholly on the west side of Gap Creek; and being the same conveyed unto me, the said R. E. Johnston, by Willie Pruitt, by deed April 22, 1904, and recorded June 15, 1904, in Deed Book LLL at page 704.

Second, that tract lying on the east bank of Gap Creek, and only separated by said Creek from the tract last above described. Beginning at a Mahogany 2xom on said Gap Creek, and running thence S 61 E along the line of the "Willie Pruitt home tract" 53.50 chains to a pine 3xom (down); thence N 9½ to a chestnut 3xom on Bear House Ridge; thence N 38 W 9.00 chains to a maple 3xom on Gap Creek; near the "Winds"; thence down the said Gap Creek, following the meanders thereof to the beginning corner, containing 68 acres, more or less, and being the same tract conveyed unto me, the said R. E. Johnston, by the said Willie Pruitt, by another deed dated April 22, 1904, recorded June 15, 1904, in Deed Book LLL at page 698; both of these tracts described having been carved out of a certain tract of land, containing 155 acres, which was conveyed to the said Willie Pruitt by Patience Pittman (formerly Patience Pruitt) by deed March 21, 1904, recorded March 26, 1904, in Deed Book LLL, at page 503, and conveyed to the said Patience Pruitt by Jacob Pruitt, by deed June 30, 1873, recorded September 1, 1873, in Deed Book FF, at page 31.
