Dollars, to be paid One year after date, at the rate of 7% per annum, and shall bear interest from the date of this note until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid; then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of ten per cent of amount due besides all costs and expenses of collection to be added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage; as in and by the said note, reference being thereunto had, as will more fully appear.)

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said

Bessie Morris Tilmann, her heirs and assigns forever All that lot of land situate in the State and County aforesaid, near the City of Greenville, East of the Augusta Road in the subdivision known as Hammetts, designated as Lot No. 11, Block E, on a revised plat of said property recorded in Plat Book 7, page 131, having the following metes and bounds:

Beginning at a stake on the South side of Curzon Street, 121 feet from the corner of an unnamed street, and running thence along Curzon Street N. 55-21 E. 60.5 feet to a stake corner of Lot No. 12; thence along the line of said lot No. 12, 134.8 feet to a stake corner of Lot No. 3; thence along line of lot No. 3, 60 feet to stake corner of Lot No. 10; thence along line of Lot No. 10, 127.2 feet to the beginning.
