TO ALL WHOM THESE PRESENTS MAY CONCERN:

X Stella K. Lindal

SEND GREETING:

WHEREAS, I, the said *Stella K. Lindal*, in and by my certain promise, even date with these presents, *X B. Lindal*, in the full and just sum of *\$22,400.00* Dollars, to be paid, Twenty two Thousand four hundred and *70* cents, one year after the date

with interest thereon, from *date car 1935*, at the rate of *7* per cent. per annum, to be computed and paid *22nd day of May - 1935*.

Until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid; then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of *One hundred cent*.

I, B. Lindal, do hereby agree, *for and in consideration of the sum of \$22,400.00*, to pay to the said *Stella K. Lindal*, besides all costs and expenses of collection to be added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind, all of which is secured under this mortgage; as in and by the said note, reference being thereunto had, as will more fully appear.)

NOW, KNOW ALL MEN, That *I, Stella K. Lindal*, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said *X B. Lindal*,

according to the terms of said note, and also in consideration of the further sum of Three Dollars, to *Stella K. Lindal*,

in hand well and truly paid by the said *X B. Lindal*,

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said *X B. Lindal*,

those three certain lots, so called in Ward six of the City of Greenville being described as follows: No. 1, commencing at a point on the South side of Crescent Avenue, corner of lot #30, shown on Map of Crescent Terrace, made by R. E. Dalton, Engineer, July 1919; thence with Crescent Avenue S. 84-40 W. 140 ft. to a point on Crescent Avenue N. E. corner of a triangle, place of Mrs. Stella K. Lindal, thence S. 5-41 E. 200 ft. to an alley; thence with alley N. 84-40 E. 140 ft. to a point on line of lot No. 30, thence with line of said lot N. 5-41 W. to the beginning corner No. 2. Commencing on the South side of an Alley on Capers Street 210 ft. from N. E. corner of Crescent Avenue and Capers Street; thence with Capers Street 200 ft. to corner of lot No. 77 as shown on said plat; thence with line of lot #77 N. 84-40 E. 200 ft. to a stake; thence N. 85-41 W. 200 ft. to a point on Alley; thence with Alley S. 84-40 W. 200 ft. to the beginning corner.

No. 3. All of lot No. 20 as shown by plat aforesaid on the North side of Crescent Avenue, said lot being shown on said plat as having a frontage of 70 ft. with a depth of 295.9 ft., excepting however a strip of five feet in width extending along the West side of said lot.
