with interest thereon, from..... at the rate of *8* per cent. per annum, to be
 computed and paid. *50/yr.*

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid; then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of.....

.....besides all costs and expenses of collection to be added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage; as in and by the said note, reference being thereto had as will more fully appear.)

NOW, KNOW ALL MEN, That..... the said *W. B. Bridwell*,

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said *J. J. Loftis*,

according to the terms of said note, and also in consideration of the further sum of Three Dollars, to *W. B. Bridwell*, the said *J. J. Loftis*,

in hand well and truly paid by the said *W. B. Bridwell* *J. J. Loftis*

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents, do grant,

bargain, sell and release unto the said *J. J. Loftis* all that piece, parcels, & parts of land in Chick Springs Township in Greenville County,
 State of South Carolina near Chick Springs 0.0 on Mountain Creek, Branch Waters of Enoree River, bounded by lands of Wm. Southern, J. W. Martin & others and having the following lines and boundaries.

Beginning at an iron rod on the E side of Road leading toward Mountain Creek & River, thence N. 37 E. 6.00 chains to a stone, thence N. 31 $\frac{1}{2}$ E. 4.44 chains to a stone, thence S. 14 $\frac{1}{2}$ E. 8.08 chains to a stone, thence S. 24 $\frac{1}{4}$ W. 14.44 chains to an iron rod in old mound, thence N. 36 W. 6.11 chains to an iron rod, thence N. 18 $\frac{1}{4}$ W. 7.91 chains to place of beginning, containing 14. 410 acres more or less.
