with interest thereon from date 9/4/27 at the rate of 7 per cent. per annum, to be computed and paid annually \$94.97

and I hereby agreed to pay, and I do hereby agree to pay, all interest on said note when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time unpaid, then the whole amount evidenced by said note, to become immediately due, at the option of the holder hereof, who may sue therefor at any time and in any court of law or equity, after maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place, and the holder should place, the said note, or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses, including 10 per cent. of the indebtedness as attorney's fees, to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.
