in Section 5, T-16-S, R-1-E, all in Vermilion Parish, Louisiana. Included in this lateral loop section is a valve and scraper trap assembly at the beginning of the loop section, a valve and scraper trap assemblies at M.P. 10.72 and M.P. 10.74.

One 6-inch lateral pipe line approximately 0.13 miles in length, beginning at M.P. 9.27 on the 6-inch West White Lake Lateral pipe line and continuing in a southerly direction to the Union Oil Platform, all in Section 6, T-15-S, R-1-W, all in Vermilion Parish, Louisiana. Included in this lateral pipeline section is a 4-inch valve and a 4-inch check valve at the beginning and a 6-inch valve and a 2-inch valve at the Union Oil Platform.

One 4-inch lateral pipe line approximately 0.85 miles in length, beginning at Union Oil of California Platform No. 2 and continuing in a northwesterly direction to the point of the tie-in with a 6-inch lateral, all in Block 35, Vermilion Area, offshore, Louisiana.

One 6-inch lateral pipe line approximately 0.28 miles in length, beginning at a 6-inch valve at M.P. 14.15 on the 16-inch lateral line from Block 67 to Block 131, and continuing in a southwesterly direction to the riser at the Forest Oil Company Platform all in Block 129 Vermilion Area, offshore, Louisiana.

One 16-inch lateral pipe line approximately 21.42 miles in length, beginning at a tee in the 16-inch line from Block 67 to Block 76 at M.P. 1.56, and continuing in a southeasterly direction to the riser at Mobil "A" Platform in Block 131, all in offshore Vermilion Area, Louisiana. Included in this lateral line section is a 16-inch hypresphere valve at M.P. 0.22; 6-6 inch valves at M.P. 4.17, 7.73, 12.99, 14.14, 18.20 and 20.49; and a 16-inch check valve at M.P. 21.32.

One 6-inch lateral pipe line approximately 2.27 miles in length, beginning at Union Oil of California Platform Block 35 SM-1 and continuing in a northwesterly direction to Gulf Oil Auxil. Platform in Block 23SM-1, all in offshore South Marsh Island Area, Louisiana.

One 6-inch lateral pipe line approximately 0.02 miles in length, beginning at the 6-inch valve on the existing 16-inch lateral at M.P. 18.57 and continuing in a northerly direction to the Kerr-McGee Platform "B" all in Block 33, offshore Ship Shoal Area, Louisiana.

One 20-inch lateral pipe line approximately 36.28 miles in length, beginning at Mosquito Bayou Junction, located in Section 1, T-21-S, R-12-E, Terrebonne Parish, Louisiana; and continuing in a south and southwesterly direction to Gulf Platform in Block 129, offshore Eugene Island Area, Louisiana. Included in this lateral pipeline are one 20-inch gate valve, two 20-inch check valves, and ten 4-inch valves.

One 10-inch lateral pipe line approximately 19.37 miles in length beginning at the 10-inch riser Block 87 and continuing in a south-westerly direction to the 10-inch riser in Block 169 all in the Ship Shoal
