NOW THEREFORE THIS (DEED OF TRUST) MORTGAGE WITNESSETH: That in consideration of the sum of One Dollar (\$1.00) paid to the First Parties by the Second Parties, the receipt whereof is hereby acknowledged by the said First Parties and in consideration of the acceptance of the Second Parties of the trusts hereinafter set forth, which acceptance of the Second Parties is evidenced by their authentication of the said notes, the First Parties hereby grant and convey unto the Second Parties, their survivor and successors, certain real estate situated in the County of Greenville, State of South Carolina, and described as follows, that is to say; All that piece, parcel or lot of land situate, lying and being

just outside of the corporate limits of the City of Greenville, County of Greenville, State of South Carolina, and being known and designated as Lot No. 10 on a plat of the property of Mrs. J.O. Lewis, recorded in the R.M.C. Offuce for Greenville County in Plat Book "F" at page 135, and having according to a plat thereof prepared by C.H. Millard, Engineer, August 1926, the following metes and bounds, to-wit:
