Nesbitt in consideration of the said debt and sum of money as aforesaid and for the better securing the payment thereof, the said PIEDMONT SAVINGS AND TRUST COMPANY, according to the condition of the said note or obligation, and also in consideration of the further sum of FIVE DOLLARS, to me, the said Irene B. Nesbitt

in hand well and truly paid by the said PIEDMONT SAVINGS AND TRUST COMPANY, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged) have granted, bargained, sold and released, and, by these presents, do grant, bargain, sell and release unto the said PIEDMONT SAVINGS AND TRUST COMPANY, all that tract or parcel of land, situated in County of Greenville, State of South Carolina, and described as follows:

In the City of Greenville, on the north side of Carle Street, known as the southeast quarter of lot No. 9 on a plat recorded in the R.M.C. Office for said County in Plat Book "C" at page 10 and having the following metes and bounds, to wit:

Beginning on the north side of Carle Street, 100 feet west of Robinson Street, at corner of Lot No. 10, and running thence N. 1-05 E. 208 feet; thence N. 86-05 W. 50 ft., thence S. 1-05 W. 208 feet to Carle Street; thence with Carle Street S. 86-05 E. 100 feet to the beginning corner and
