all that piece, parcel, or lot of land situate and
being in the County and State aforesaid, in Cleve-
land Township, on the South side of Echo Drive, and
having the following metes and bounds, to wit:
Beginning at a stake on Echo Drive, corner
of lot 61, and running thence with Echo Drive, n.
21-25 w. 100' to a stake; thence with line of lot 65
s. 69-10 w. 150' to a corner; thence with line of Cliff
120' more or less, to the corner of lot 61; thence n.
