all that certain piece, parcel or lot of land situate, lying and being in Greenville Township state and county aforesaid, near the City of Greenville, known and designated as Lot No. 84 of the Subdivision of Greenville, known and designated as Park Blocks of the sub division known as Augusta Circle as shown on a plat of record in the R.M.C. Office for Greenville County, South Carolina, in Plat Book F, page 28, and having the following metes and boundaries, to wit:

Beginning at an iron pin on the Northwest corner of Winyah Street and Tomassie Avenue and running thence with Tomassie Avenue N. 21-30 E. 50 feet to iron pin, joint corner of lots 82 and 83; thence with the joint line of said lots N. 71-30 W. 150 feet to iron pin, joint corner of lots 82, 83, 100 and 101; thence with the joint line of lots 82 and 101, S. 21-30 E. 50 feet to iron pin on Winyah Street. thence with Winyah Street S. 71-30 E. 100 feet to the beginning corner, this is a junior mortgage over said property.
