maker agrees to pay fifty dollars upon principal sum each year of renewal),with interest thereon, from date at the rate of 8 per cent. per annum to be  
computed and paid semi-annuallyuntil paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may  
sue thereon and foreclose this mortgage, said note further providing for an attorney's fee often per cent. besides all costs and expenses of collection, to be

ncoer, Treasurer, its successors and assigns, All that certain piece, parcel or lot of land  
situated, lying and being in the County of Greenville, State of South Carolina, and in  
subdivision known as Westview, near Judson Mills, being part of Lot Number Four on plat of  
property of J.O. Heatherly recorded in plat Book E, at page 235, and being the portion of  
said lot Number Four conveyed to me by Annie Huskamp by her deed dated May 22, 1925, and  
recorded in Vol. 105, page 375, R.M.C. Office for Greenville County, and having a frontage of  
57.6 feet on Godrich Street, a depth of 118.4 feet on its western side, a width of 65.6
