- 49. All that 13,000 volt single circuit wooden pole line extending from High Rock, N. C., to Bald Mountain, N. C., and being approximately 6.46 miles in length and located in Stanly County, North Carolina.
- 50. All that 13,000 volt single circuit wooden pole line extending from the City of Salisbury, N. C., to the Town of Rockwell, N. C., and being approximately 10 miles in length and located in Rowan County, North Carolina.
- 51. All that 11,000 volt single circuit wooden pole line extending from the Catawba Plant of Duke Power Company, in the County of York, S. C., to the Towns of York and Clover, S. C., and being approximately 26 miles in length and located in York County, South Carolina.
- 52. All that 11,000 volt single circuit wooden pole line extending from Fort Mill Junction, S. C., to the Town of Fort Mill, S. C., and being approximately 4 miles in length and located in York County, South Carolina.
- 53. All that 11,000 volt single circuit wooden pole line extending from Pineville Junction, N. C., to the Town of Pineville, N. C., and being approximately 7 miles in length and passing through the County of York in South Carolina and the County of Mecklenburg in North Carolina.

54. All that 13,000 volt single circuit wooden pole line extending from West Spartanburg, S. C., to Fairmont, S. C., in Spartanburg County, S. C., and being approximately 7 miles in length and located in Spartanburg County, South Carolina.
