 ed hypothecated or otherwise disposed of, and that the same has been law-  
 ful destroyed and after diligent search cannot be found. That deponent further  
 authorizes me to mark the Mortgage satisfied and canceled or record.

 grant, bargain, sell and release unto the said *W. R. Hale*, Trustee, his heirs

and assigns forever all that piece of land or  
 lot of land situate lying and being in  
 Grand Township, Greenville County, State of South  
 Carolina, and having the following metes  
 and bounds, Beginning at B. D. Cothran's  
 corner conveyed to Cothran by H. K. Towns,  
 in the center of the public road and  
 running thence with center of said road,  
 N. 63-30 W. 200 feet, thence N. 78-45 W. 195 feet,  
 thence S. 85-10 W. 600 feet, thence S. 77-45  
 W. 33 feet to Richey's corner in the center of  
 said road, thence crossing the road S.  
 85-0 W. 550 feet, thence S. 72-0 W. 123 feet,
