in and by my certain promissory notes bearing date the 1st day of September A. D. 1928, stand firmly held and bound unto MORTGAGE GUARANTEE COMPANY OF AMERICA, a corporation created and existing under the laws of the State of Delaware.

In the Principal sum of \$7,800.00, payable as follows: \$200. Sept. 1st. 1929; \$200. Sept. 1st. 1930; \$300. Sept. 1st. 1931; \$300. Sept. 1st. 1932; and balance of \$6,800 Sept. 1st. 1933; with interest at the rate of 7% from date payable semi-annually at Atlanta, Ga. It is expressly agreed that should any of the interest become past due it shall bear interest at the rate of 8%, and upon failure to pay any of said interest when due the principal sum shall, at the option of the holder become due and collectible. Time is of the essence of this contract: in case this mortgage or any part of it is collected by law or through an attorney or binder the expenses thereof, and costs of collection including ten per cent of the principal and interest as attorney fee shall be paid by the mortgagor. After the maturity of any of the above notes the same shall bear interest at the rate of eight per cent per annum.

at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents, do grant, bargain, sell and release unto the said MORTGAGE GUARANTEE COMPANY OF AMERICA, its successors and assigns, all that tract or parcel of land.....
