Tract no. 1. All that certain lot of land on the North side of Randall Street, beginning at a point 282 feet from the northeast corner of the intersection of Randall and Rutherford Street and running thence N. 1-41 E. 150 feet to corner of lot 6 of section "A" thence S. 1-41 E. 150 feet to corner; thence S. 1-41 W. 150 feet to corner and North side of Randall Street; thence along the North side of Randall Street N. 85-39 W. 52 $\frac{1}{2}$  feet to the beginning corner being a part of Lot no. 6 of section A, on plat of ~~Stone~~ Land Company lands, which Plat is recorded in the Office of Register, for said County and Stated in Plat Book "A", at Pages 337 to 345.
