Now, therefore, in consideration of the premises, and in further consideration of one dollar to him in hand paid, the receipt whereof is hereby acknowledged, the said party of the first part has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the said party of the second part all that certain piece, parcel and lot of land lying in Greenville County, in the State aforesaid, as follows, to-wit:

Being a portion of Lot No. 60 as shown on plat of said subdivision near Casley Bridge Road, property of Looper & Yawn, recorded Plat Book 7, page 77 and bearing the following courses and distances:

Beginning at a narrow pin on the Northwest corner of Gaffin Street and White Horse Road and running thence with White Horse Road N. 11° 56' feet to stake, thence S. 79-45 W. 152 feet more or less to stake in line of lot hereinafter described, thence with line of said lot S. 10-15 E. 63 feet to stake on Gordon Street, thence with Gordon Street N. 79-45 E. 135 feet to the beginning.

Also: all that other lot in Township and County and State aforesaid, adjoining the lot above described, being a portion of said lot No. 60 on plat of Looper & Yawn property described as follows:

Beginning at a stake on North side of Gordon Street 145 feet West of the White Horse Road and running thence with Gordon Street S. 79-45 W. 50 feet to a narrow pin, corner of lot No. 58, thence with line of said lot N. 10-15 W. 150 feet to stake, corner of Mary Chandler lot, thence with Mary Chandler lot N. 79-45 E. 50 feet, thence S. 10-15 E. 150 feet to the beginning, being the same conveyed to Greenville Trading Company by John A.
