Begging at a stake on said Vulcan (now Manly) Street and Lot No 14, and running thence with line of lot No 14, N 77 E. 186 feet to a stake in line of lot No 11, thence N 13 E. 68 feet to a stake in line of lot No 11, and corner of lot No 12; thence with the line of the last mentioned lot S. 77 E. 186 feet to a stake on Vulcan (now Manly) Street, and thence with said Street S. 13 E. 68 feet to the beginning corner, containing 2 1/2 acres, more or less, and being the same lot of land conveyed by J.
