Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of *January* 192*9*, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of *Three + 98/100* Dollars, (*\$3.98*)

being the regular monthly installment payable on the *two + 50/100* Shares of Stock, and *one + 48/100* Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of *Three + 67/100* Dollars, (*\$3.67*)

Dollars, being the regular monthly payment on said stock and *two + 67/100* Dollars, being the monthly interest on balance due); for the next twenty months the sum of *Three + 38/100* Dollars, (*\$3.38*)

Dollars, being the regular monthly payment on said stock and *88/100* Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *Three + 08/100* Dollars, (*\$3.08*)

Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *Two + 79/100* Dollars, (*\$2.79*)

Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter *be credited as a payment upon the advance or loan made*, the said *A. C. Summey* and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against the said *A. C. Summey*

News, and recorded in Plat Book C, page 107, said lot having a frontage of 51 feet on the west side of Middle Street with a depth of 150 feet. This is the same lot conveyed to me, A. C.
