WHEREAS, I, the said Laura Elliott White

in and by my certain promissory note in writing, of even date with these presents am well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in the full and just sum of Fourteen hundred no. 1100 19th Dollars,

Laura Elliott White in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION at and before the signing of these Presents, the receipt thereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING AND LOAN ASSOCIATION all that piece, parcel or lot of land lying in Greenville County, South Carolina,

In Greenville Township, near the Corporate limits of the City of Greenville, on the North side of the 35 Early Bridge Road; Beginning at a stake 180 feet west of the intersection of said Early Bridge Road and Florida Avenue, and running thence in a northwesterly direction 181 feet to iron pin in line of lot No. 11-1 on plat hereinafter referred to; 219 1:00 thence with line of said lot 24 in a westerly direction 60 feet to pin; thence S. 170. 181 feet to iron pin on Early Bridge Road; thence with said Road N. 71 E. 60 feet to the beginning being a portion of lot no. 24-6 on plat of West Highland recorded in great book C, page 258-259.
