All that certain lot of *Acres* of land in Greenville County, State of *South Carolina* in Paris Mountain Township containing *14* acres, more or less and more particularly described as follows: Beginning at a *corner* in the south-east corner of lot *5* to *behave* on the line between *behave* and *Stewart* and running thence with the north line of *Stewart* property *n. 88° 11' 11"* feet to a *pine* on *Lodgston* Creek, thence with said *creek* *n. 12° 11' 68"* feet; thence with said *creek* *n. 20° 1/2° 837"* feet to *iron* stake in *creek* in *new* road running to *lane* *Souci* *Club* *House*; thence with said *road* *n. 18° 11' 1337"* feet to the *near* corner of *Hamilton* lot; thence with *Hamilton* and *behave* line *s. 4 1/4° 624"* feet to the *beginning* point.
