all that tract or lot of land in Greenville

Township, Greenville County, State of South Carolina.

Being known and designated as Lot nos. 5 and 6 on Plat of Property of Mrs Leila Hayes, which is recorded in Office of P.M.C. for Greenville County in Plat Book - at Page - and having, according to said Plat the following Metes and Bounds, to-wit:

Lot No. 6: Beginning at a point on the Southern side of a proposed 25' Street at the corner of Lot No. 2 on said Plat, which point is 200 feet from the Eastern side of Paris Mountain Road, and running thence along line of lot No. 2 S. 13-45 E. 8 ft. more or less, to a point, thence along line of lots Nos. 2 and 1 S. 20-30 E. 98 feet, more or less to a point in Southern side of Property of Leila Hayes, being the S. E. corner of Lot No. 1; thence in said Easterly direction 55 ft. more or less, to the corner of Lot No. 7; thence along line of Lots Nos. 7 and 8 in a northerly direction 105 ft. more or less, to a point on the Southern side of the proposed 25 ft. Street; thence along the Southern side of said proposed 25 ft. Street in a Westerly direction 80 ft. more or less, to the beginning corner. Lot No. 5: Beginning at a point on the Northern side of a proposed 25 ft. Street, which point is 200 feet from the Eastern side of Paris Mountain Road and is the Southern Eastern corner of lot No. 3; and running thence along line of said Lot No. 3 N. 13-45 W. 35 feet, more or less, to a point thence continuing along line of said lot No. 3 and lot No. 4 N. 4-30 E. 210 ft. to the N.E. corner of lot No. 4; thence along Northern line of Property of Leila Hayes in an Easterly direction 145 ft. more or less to the N.W. corner of lot No. 12; thence along line of Lots Nos. 12, 11, 10, and 9 in a Southerly direction 232 ft. more or less, to the S. W. corner of lot No. 9 on the Northern side of said proposed 25 ft. Street; thence along Northern side of said proposed 25 ft. Street in a Westerly direction 81 feet, more or less, to the beginning corner. Both of these lots are cut out of the property conveyed to me by J.H.
