SEND GREETING:

WHEREAS, E. S. Ballenger, the said E. S. Ballenger,  
in and by 11 certain April 1930 note in writing, of  
even date with these presents, unpaid well and truly indebted to

Greer Bank & Trust Company  
in the full and just sum of Sixty Standard Dollars and 50 cents  
Dollars, to be paid Six months after the date of these

satisfactory to the mortgagor

with interest thereon, from 27/28/30 at the rate of 8 per cent. per annum to be  
computed and paid annually for the year 1930

until paid in full all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal
