Also, doth acknowledge and assign, that I, Alice L. Russell, of the City of Greenville, County and State aforesaid, planting about office street; beginning at a corner pine at the corner of Coffee and Mc. Bee Streets, and running with said pine tree N. W. 206.130 feet toward a pine at the corner of said Mc. Bee Street and a 10 foot alley, enclosed with said 10 foot alley S. 70° E. 35 feet to a corner pine, enclosed S. 20° N. 130 feet to another pine on Coffee Street; enclosed with said Coffee Street N. 70° W. 35 feet to the beginning corner, containing 16/100 of an acre, described as Lot 2 and 1/4 of Plat of J. W. Southern, D. L., May 24, 1898.

Also, doth acknowledge and assign, that I, Alice L. Russell, of the City of Greenville, County and State aforesaid, planting about Coffee Street; Beginning at a corner pine on said Coffee Street, said pine being corner pine of lot purchased by T. J. Captain, from J. B. Beattie and Perry D. Miller, by deed dated July 30, 1898, and running N. W. 206.130 feet to another pine in a 10 foot alley; enclosed with said alley S. 70° E. 13 feet to another pine, enclosed S. 20° N. 130 feet to another pine on Coffee Street; enclosed with Coffee Street N. 70° W. 13 feet to the beginning corner, said being a portion of Lot No. 4 of a plat of Plat of J. W. Southern, D. L., May 24, 1898.
