Lucas L. Watson, as Trustee
 in the full and just sum of *One thousand dollars*,
 Dollars, to be paid *and all interest from date*

Presently due
 with interest thereon, from *Date of note* ^{3%} at the rate of *per cent. per annum to be*
 computed and paid *Presently due*
until paid in full all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal
or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who may
sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of ~~10% of the amount due~~
besides all costs and expenses of collection, to be
added to the amount due on the said note, to be collectible as a part thereof; if the same be placed in the hands of an attorney for collection, or if said debt, or any part
thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being
thereunto had, as will more fully appear.

according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to *W. L. L.*, the said *W. L. Henderson*,

 at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released and by these Presents do grant, bar-
 gain, sell and release unto the said *Lucas L. Watson, as Trustee, her*

successors and assigns,

All those three certain lots of land situate,
 on the Western side of Manzell Street in the City
 and County of Greenville, South Carolina and
 described as follows:

1. All that lot of land beginning at the said street
 at the corner of the R. W. Walker land before the same is described
 northwesterly direction 90 feet in the line of the
 R. W. Zimmerman lot; thence along the line of
 that lot 35 feet; thence in a line parallel with
 the first line above given 90.8 feet to Manzell St;
 thence in a due westerly direction along Manzell
 Street 35 feet to the beginning corner.

2. All that lot of land beginning at the south
 and west side of Manzell Street 35 feet north-
 east from the corner of the R. W. Walker lot, which
 point is at the northeast corner of the lot just above
 described and runs thence in a northwesterly
 direction along the line of the lot above described
 91.8 feet in the line of the Sam R. Zimmerman lot;
 thence in a northeasterly direction along the line
 of that lot and of the T. H. Brin lot 70 feet; thence
 in a straight line to Manzell Street 60 feet from the
 beginning corner; thence along Manzell Street 60
 feet to the beginning corner.

3. All that lot of land beginning at a point on
 the western side of Manzell Street at the northeast corner
 of the lot last above described and runs along the
 line of that lot in a northwesterly direction 91.7
 feet in the line of T. H. Brin lot; thence along
 that line in a northeasterly direction 40 feet; thence
 in a line parallel with the first line of this lot
 as a line given 12 feet to Manzell Street; thence
 in a southwesterly direction along Manzell Street 40
