All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, in Greenville Township, beginning at a stake on the corner of lot No. 3 and running thence Easterly fifty feet to a corner of lot No. 5; thence North 106.6 feet to a pin on corner of lot No. 5, adjoining Mr. Cauley's property; thence Westerly 50 feet to pin on corner of lot No. 4 and Mr. Cauley's property; thence South 107.6 feet to the beginning corner on Harley Street, and being known as lot No. 4 of subdivision of W.
