MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

SEND GREETING:

WHEREAS, I, the said Maria Kiriakides, in and by my certain Promissory note, in writing, of even date with these presents, am well and truly indebted to Walter W. Goldsmith in the full and just sum of Two hundred and Seventy five dollars Dollars, to be paid at the rate of \$1.25.00 per month beginning February 1st 1930 until paid in full.

with interest thereon, from date semi-annually secured instrument until paid in full, interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of 10% of amount due, besides all costs and expenses of collection, to be added to the amount due on the said note, to be collected as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereto had, as will more fully appear.

NOW, KNOW ALL MEN, That the said Walter W. Goldsmith, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Walter W. Goldsmith according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me, the said Maria Kiriakides, in hand well and truly paid by the said

Walter W. Goldsmith, at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released and by these Presents do grant, bargain, sell and release unto the said Walter W. Goldsmith, his heirs and assigns forever;

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in the City of Greenville on the Northwest corner of Whitsett Street and Carolina Avenue, and known as Lot No. 6 of Block 8 on the plat made by J. R. Lawrence, revised January 22nd 1908, and recorded in Plat Book A, Page 179, said lot being described as follows:-

Beginning at an iron pin on the North side of Whitsett Street and running thence N. 15° W. one hundred twenty six feet and one inch to an iron pin on a ten foot alley; thence S. 76-45° E. seventy six feet and eight inches to an iron pin on Carolina Ave; thence S. 15° E. one hundred twenty six feet and one inch to an iron pin on Whitsett street; thence S. 76-45° W. seventy six feet and eight inches to an iron pin, the beginning corner.
