WHEREAS, *\$ 119*, the said *E. J. Gault*

 even date with these presents, *one* well and truly indebted to *Mrs. Beallie M. Babb*

 in the full and just sum of *one hundred*
 Dollars, to be paid *on or before the first day of November 1930*

with interest thereon, from *date* at the rate of *8* per cent. per annum to be
 computed and paid *annually* until paid in full all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal
 or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may
 sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of *ten percent*

.....besides all costs and expenses of collection, to be added to the amount due on the said note, to be collectible as a part thereof; if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereto had, as will more fully appear.

 in hand well and truly paid by the said *Mrs. Beallie M. Babb*.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released and by these Presents do grant, bar-
 gain, sell and release unto the said *Mrs. Beallie M. Babb her heirs and assigns*.

 situate in the State and County of *Greenville* in *South Carolina* of ownership and near the Town of *Mountain Home* as
 follows:

Lots numbers 13, 14, 23 & 24 Lots numbers 11 & 12,
 15 & 16 and 21 of the subdivision of the *J.W. Givens*
 land as is shown by a plat made by *J. A. Adams*,
 survivor on the 29th day of March 1910 and
 recorded in plat book at page 280 in the
 Q.M.C. office for Greenville County. Each lot
 being 50 feet wide and 150 feet deep. These being

H. N. Givens, *Mrs. Lizzie & H. S. Givens*,
F. S. Peders *J. J. Babb*, all of which are recorded in the
 Q.M.C. office for Greenville County in book 41

 85, book 42 at page 196 and book 56 at page 349
 respectively. Bounding on the Greenville & Laurens
 public highway 330 feet and being the same
 lots upon which my present residence is
 situated.

 Public Highway, lots numbers 17, 20, 22, 25, 26
 and 10 and a city-foot street, not used on
 the line of the *J.W. Givens* estate land.
