Beginning at a seam in the abutment of the Buck Shoals Dam where the said dam and abutment joins, and running thence N. 5 W. 1 chain; N. 39 W. 5 chains; N. 50½ W. 6.50 chains to the mouth of Zachary's Spring Branch; N. 40 E. 1 chain to the middle of Ararat River; thence up the said river as it meanders 56.50 chains, more or less to the mouth of Stewart's Creek; thence up said creek as it meanders 64.40 chains, more or less, to Doss' corner on the South side of Stewart's Creek; thence S. 33 E. 30.50 chains to the Buck Shoals road; thence with said road as it meanders 71 chains, more or less, to Brower's line; thence about North 4.85 chains to a Pine stump, Brower's corner; thence about N. 50 E. 17 chains to the Ararat River; thence up said river about N. 45 W. 9 chains to the beginning, containing 350 acres, more or less, and being the lands upon which the aforesaid rights, privileges, and easements were conveyed to the said Town of Mount Airy by W. McKinney and wife by deed dated June 23, 1905, and recorded in Book 45, page 323.
- (C) The right, privilege and easement to maintain, repair, alter or change, with proper poles, towers, wires, braces and other necessary or useful appliances, a transmission line for the purpose of transmitting electric current from the aforesaid power plants formerly of the said Town of Mt. Airy situate upon the Ararat River to the Town of Mt. Airy, being the same rights, privileges and easements conveyed or accruing to the said Town of Mt. Airy as hereinafter set out, to-wit:
- 1. By purchase from Wilcher Banner, across that tract of land known as the Wilcher Banner 200 Acre Home Tract, lying between and bounded by Lovell's Creek and the Ararat River on the South, and the corporate limits of the Town of Mt. Airy on the North.
- 2. As conveyed to the Town of Mt. Airy by Mrs. Anne R. Moore, et al., by deed filed for registration December 20, 1905, and recorded in Book 45, Page 599, and as set out in judgment of Superior Court recorded in Minute Book No. 11, Page 304.
- 3. As conveyed to the Town of Mt. Ary by Sherman Bundy, by deed dated May 3, 1919, and recorded in Book 77, Page 77.
- 4. As conveyed to the Town of Mt. Airy by H. Shaefer, by deed dated May 13, 1919, recorded in Book 77, Page 69.
- (D) All the buildings, structures, machinery, tools and appliances, including all waterwheels, generators and apparatus of every kind constituting a part and parcel of and being necessary and useful to the power plants of the Company, situate as aforesaid upon the Ararat River, for the generation and manufacture of electric current; also all that certain electric distributing system with the poles, wires, transformers, lamps, insulators, crossarms, meters and all and every machinery, apparatus and material incident thereto or connected therewith or useful therein, situated and located within and around the Town of Mt. Airy, and used in or useful for the transmission and distribution of electric power in and around the aforesaid power plants and Town of Mt. Airy.

It is the intent and purpose of this instrument to convey to the Trustee the entire plants for the generation of electric power as aforesaid, and the entire system for the transmission and distribution of the said power, together with all the rights, privileges, easements, interests and immunities owned, exercised, enjoyed or in anywise accruing to the Company in respect to the same. The various instruments hereinbefore mentioned are recorded in the Offices of the Register of Deeds and of the Clerk of the Court respectively for said Surry County, and reference is hereby made to the same.

ALL transformers, poles, wires, crossarms, insulators, meters, rights-of-way, and other property constituting the electric distribution and lighting system of the Company used, or held for use, in connection with distributing current to the Town of Stony Point, and its inhabitants, and lighting said town.

Including all property conveyed to the Company by deed of the Town of Mineral Springs, dated July 11th, 1928, recorded in the public registry of Union County, North Carolina, in Book 65, at page 595.

PARCEL NO. 39.

That electric distribution system in the Mount Olivet Community in Cabarrus County, North Carolina, described as follows:

All poles, wires, transformers, insulators, cross-arms, meters, apparatus and rights-of-way, constituting its electric distribution system, and all property owned by the Company and used, or connection with the maintenance and operation of its electric distribution system in and near the Town or Community of Mount Olivet, and also including rights of way for said transmission line now owned or now being acquired by the Company.

Including all property conveyed to the Company by deed of Monnt Olivet Electric Lines Company, dated August 31st, 1928, and recorded in the public registry of Cabarrus County, North Carolina, in Book 118, at page 203.
