Dalton recorded in Plat Book First page 20, and having the following lines and bounds, to-wit: Beginning at a iron pipe, Southwest corner of Lot No. 5; thence with said lot S. 70-27 E. 140 feet to an iron pipe in water-fall valley; thence with said valley S. 18-45 W. 54 feet to an iron pipe corner lot of 8 has. E. Mackey; thence with said lot N. 70-27 W. 140 feet to Summer Street, thence with Summer Street N. 18-45 E. 54 feet to the beginning corner, being the same lot of land conveyed to me by deed dated November 13, 1923 by Nellie S.
