with interest thereon from the date above per centum per annum, to be computed and paid monthly until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness and to be secured under this mortgage as a part of said debt.

NOW KNOW ALL MEN BY THESE PRESENTS, that I, Estelle Garrison, do hereby mortgage, sell and convey, all my right, title and interest in and to the above described property, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Utopian Developing Company, according to the terms of the said note, and also in consideration to the further sum of Three Dollars, to me, the said Estelle Garrison, in hand well and truly paid by the said Utopian Developing Company at and before signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and by the Presents do grant, bargain, sell and release unto the said

Utopian Developing Company:
 All that certain piece, parcel or lot of land situate in the subdivision known as "Northgate", lying and being in Greenville Township, Greenville County, State aforesaid, and being known and designated as lot No. 9 of Block K of the Lots of the Utopian Developing Company, as per plat of J. H. German, Jr., C. E., made June, 1930, and recorded in the R. M. C. Office for Greenville County in Plat Book "A", at pages 135-6, and having, according to said plat, the following metes and bounds to wit:-

Beginning at an iron pin on the east side of East Avondale Drive, the joint corner of lots Nos. 9 and 10; thence with joint line of said lots N. 29 E. 10.65' to an iron pin; thence N. 29 E. 10.65' to an iron pin, the rear joint corner of lots Nos. 8 and 9; thence with the joint line of said lots N. 29 E. 218.5' to an iron pin on the east side of East Avondale Drive; thence with said Drive S. 10-40 W. 70' to the point of beginning.
