the following lines and bounds, to wit:

Beginning at a stake on Dixon's Alley, corner
of lot now owned by Robert Dixon, colored, and run-
ning thence in a general Southwesterly direction
along the line of said Robert Dixon a distance
of 150 feet to a stake, thence in a general northwesterly
direction parallel with Dixon's Alley 40 feet to a stake,
thence in a general northeasterly direction 150 feet
to a stake on Dixon's Alley, thence with said Dixon's
Alley in a general southwesterly direction 40 feet
to the beginning corner, and being the same lot
