edged, have granted, bargained, sold and released and by the Presents do grant, bargain, sell and release unto the said

all those certain pieces, parcels or lots of land situate,
lying and being in the City of Greenville, County of Greenville,
State of South Carolina, known and described as a portion of lot
no 3 and lots nos 4 and 5 on a plat of the property of A.O.L. Barkdale,
et al, made by R.E. Dalton, Engineer, July 1925, and having accord-
ing to said plat the following metes and bounds, courses and
distances, to wit:

Portion of Lot no 3: Beginning at an iron pin on the East
side of North Main street, which iron pin is 71 feet on a
southerly direction from the southeast corner of North Main
and Elford Streets, and running thence S. 68-40 E. 176.5 feet
to an iron pin on the west side of a 25 foot street, thence
along the west side of said 25 foot street S. 18-07 E.
50.1 feet to an iron pipe at the rear corner of Lot no 2,
thence along the line of Lot no 2. N. 68-40 E. 176.5 feet
to an iron pin on the East side of North Main Street,
thence with North Main Street N. 18-07 E. 50.1 feet to the
point of beginning.

Lots nos 4 and 5: Beginning at an iron pin at the
southwest corner of the intersection of Brown and
Elford Streets, and running thence along the west
side of Brown Street S. 29-30 E. 59.6 feet to an iron
pipe, front corner of Lots 5 and 6, thence along the
front line of Lots nos 5 and 6, N. 60-14 E. 103.7 feet to an
iron pin on the East side of a 25 foot street, thence
along the East side of said street N. 18-07 E. 60.8 feet to
a pipe on the south side of Elford Street, thence along
the south side of Elford Street S. 60-14 E. 115.7 feet to the
beginning corner.
