All that certain piece, parcel or lot of land, with buildings and improvements thereon, being in the city of Greenville, County of Greenville, State of South Carolina, situate at the Northeast corner of the intersection of McDaniel and Crescent Avenues, and designated as Lot No. 1 on Plat of Alta Vista, which Plat is recorded in the R.M.C. Office for Greenville County in Plat Book "G" at page 20, and having, according to said Plat, the following metes and bounds, courses and distances, to wit:
