TO WHOM ALL THESE PRESENTS MAY CONCERN:

Whereas, the said *L. M. Gaffney*, in and by *L. M. Gaffney* certain *executed* note in writing of even date with these presents, is well and truly indebted to *David M. Murray* *PA* in the full and just sum of *Two Thousand Dollars \$2,000.00* to be paid *one year after date* *1914* *Ramsey*

with interest thereon from *date* at the rate of *10%* per centum per annum, to be computed and paid *semi-annually*

until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

Murray* at and before signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and by the Presents do grant, bargain, sell and release unto the said

L. M. Murray, his heirs and assigns, all that lot of land situate on *Bacone Street*, in the City and County of *Greenville*, State of *South Carolina*. Beginning on said street at the corner of the *McTeer* lot, and running thence westward Street No. 34.00 ft. 50 feet, thence 16.46 E. 86 feet, more or less; thence S. 66.32 feet, more or less; thence S. 44 E. 25 feet, more or less to the line of the said *McTeer* lot, thence with it S. 41.30 W. 9.2 feet more or less to the beginning corner, together with the right of way reserved by *S. L. Perkins* in a deed by him to *C. M. Mc Murray*, said deed dated July 15, 1907; recorded in Vol 288, page 381, this mortgage being concerning all the rights and privileges so reserved by said *S. L. Perkins* in said deed, being the same lot of land conveyed to me by *Emilie Glad Wright* in a deed dated May 25th, 1934 to be recorded simultaneously with this mortgage.
