TO WHOM ALL THESE PRESENTS MAY CONCERN:

Whereas, I, Oliver F. Going, the said Oliver F. Going, well and truly indebted to Ellen M. Going, in the full and just sum of Sixty-five Hundred (\$6500.00) to be paid one year after date,

the following described property, to-wit: All that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, in Greenville Township, Brown and designated as lot #1 of the Wade lotterian property according to a plat of the same recorded in the R. M. L. Office for Greenville County in Plat Book A, at page 163, and being the same lot conveyed to the mortgagor herein by Lucille L. Aiken by deed dated Feb. 21, 1935 recorded in the R. M. L. Office for Greenville County in Deed Book 156 at page 330, reference to which is hereby craved for a more complete description.

Also: all that certain other piece, parcel or lot of land situate, lying and being in the City and County of Greenville, State of South Carolina, on the west side of Bennett St., Brown and designated as lot #32 Section H, of the Stone Land Company according to plat of same recorded in the R. M. L. Office for Greenville County in Plat Book A at page 337, being the same lot conveyed to the mortgagor herein by J. C. Stone by deed dated Feb. 13, 1935, recorded in R. M. L. Office for Greenville County in Deed Book 98 at page 67, reference to which is hereby craved for a more complete description.
