C. office for Greenville County, State of South Carolina, in Plat Book "F" at page 23, and having according to said plat the following Miles and fmsds. to -

Beginning at iron pin on the Eastern side of Fair Road joint corners of Lots # 98 and 99, and running thence with the joint lines of said lots S. 71-35 E. 1160.7 feet to an iron pin, joint corner of lots # 84, 85, 98 and 99; thence with joint line of 84 and 99, S. 21-35 W. 50 feet to an iron pin, the joint corners of Lots Nos. 83, 84, 99 and 100; thence with the joint lines of Lots 99 and 100, N. 71-35 W. 156.3 feet to an iron pin on Fair Road; thence with eastern side of Fair Road, N. 16-30 E. 49.96 feet to the beginning corner.
