Township, Greenville County, State of South Carolina, on the
corner of Townes Street & Union and Mountain View
Avenue, in what is known as "Oaklawn Heights", of
the Bunt lands. Beginning at the southwest corner of
said street and avenue and running thence in a
westerly direction along said Avenue 75 feet to a stake;
thence in a southerly direction 170.6 feet to a stake on
a 19 foot alley; thence in an Easterly direction along
said alley 75 feet to a stake at corner of said alley and
Townes Street; thence in a westerly direction along
Townes Street 170.6 feet, to the beginning corner, and
