about twentyfour miles from Greenville Court House, containing forty one and 5/100 (41.5) acres, commencing in the center of said Franklin Bridge Road where said tract corners with the northwest corner of Lebanon Branch lot and running thence eastwardly along said Highway 8.57 feet, thence turning and running N. 35.30 E. 2772 feet to corner, thence turning and running N. 62.15 - 5.38 feet to a corner, thence turning and running S. 27 21. 10 76 feet to corner, thence turning and running S. 34.30 W. 503.6 feet, thence turning and running S. 32 W. 748.4 feet, thence turning and running N. 62.30 W. 722.7 feet to corner, thence turning and running S. 28.30 W. 64 feet to the point of commencement, the said land being the same land conveyed to the mortgagor, L.
